1. Level of Assurance

6. Conclusion

The Company provided the GHG assertion based on the requirements of ISO14064-1:2019. The GHG information for the production of International Freight Forwarding Service for the year 2024 disclosing emission of 1.136,713 tonnes of CO₂ equivalent are verified by KIOSCERT to a reasonable level of assurance, consistent with the agreed verification scope, objectives and criteria.

According to the calculation of the Company, total emissions, in tn CO2 eq, are allocated as presented below:

KIOSCERT's approach is risk-based, drawing on an understanding of the risks associated with reporting GHG emissions information and the controls in place to mitigate these. Our examination includes assessment, on a test basis, of evidence relevant to the amounts of the organization's disclosures in relation to the organization's reported GHG emissions.

We conducted our verification regarding the GHG assertion of the Company which included assessment of GHG information system, monitoring and reporting plan/protocol. This assessment included the collection of evidence supporting the reported data and checking whether the provisions of the monitoring plan, were consistently and appropriately applied.

In KIOSCERT's opinion the presented GHG assertion

-is materially correct and is a fair representation of the GHG data and information and

-is prepared in accordance with ISO14064-1:2019 on GHG quantification, monitoring and reporting.
